The Citadel is seeking a vendor to provide termite and pest control services for its barracks, athletic buildings, campus buildings, and campus residential quarters. The Offeror shall be required to perform various types of services at different intervals at each location listed herein to include the utilization of sprays, dust powder, gels, bait traps, and granular pesticides – all supplies provided by vendor. The Citadel takes no responsibility for the accuracy of the square footage herein. The Offeror shall be solely responsible for verifying the accuracy of the square footage of the campus locations listed herein. The Offeror shall be required to perform weekly, monthly, and quarterly service per the schedule listed herein. The Offeror shall provide The Citadel Physical Plant with a receipt for each individual location it has service prior to departing the campus during each visit. The Offeror shall invoice The Citadel on a monthly for each Lot. Offeror services shall be performed in accordance with applicable Local Municipal, State, and Federal, rules, regulations and laws. The Citadel may seek additional application for any of the locations listed herein on an as need basic, therefore, the Offeror shall include these additional application fees in their monthly/quarterly service charge when submitting their bid cost. The Citadel intends a one (1) year agreement with four (4) options to renew.

1.2 Offeror shall provide chemicals that are safe to use in a nonstop working environment. Offeror must comply with current EPA and Federal Insecticide, Fungicide, Rodenticide, Act requirements and specifications. Offeror shall provide a material safety data sheet to The Citadel's safety coordinator for all chemicals that will be utilize in the performance of the pest control management program.

Barracks

1.3 Pest Control: During the month of August, the Offeror shall treat all cadets living quarters listed herein with insect bait pesticide at Steven's, Watts, Law, Padgett-Thomas, and Murray barracks once a year and each sequential year thereafter during the same time frame. The Offeror shall under no circumstance use pesticide sprays or any other product in a cadet living quarters without the express permission/consent of the citadel's contract administrator or coordinator. The Offeror shall treat the common areas of Steven's, Watts, Law, Padgett-Thomas, and Murray barracks (guard rooms, sally ports, galleries, stairwells, and latrines) monthly with pesticides approved by The Citadel's contract administrator or coordinator. The Offeror shall treat the Barracks Exterior perimeter only on a Monthly basic.

<u>Termite inspection and treatment:</u> Inspection and treatment of termites in the barracks will be accomplished between the months of July 1st and Aug 1st to ensure that disruption to cadets is avoided. Additional work in the barracks during any other time of the year will be coordinated by the contracts administrator.

See Barracks bidding schedule.

Athletic Buildings

1.5 The Offeror shall perform once a year pest control treatment in the interior of the following athletic facilities: Johnson Hagood Stadium (during football season) Deas Hall, McAlister Field House, Vandiver Hall, Earle Tennis Center, and Seignious Hall during the month of August and each sequential year thereafter. The locker rooms at these athletic facilities listed herein shall be visually inspected monthly plus be treated on an as need basic. The Offeror shall perform a perimeter barrier to the exterior of the athletic facilities listed herein by utilizing spray, dust powder, granules, an etc. to reduce the number of pest entering the location on a monthly basic should the Athletic Department or The Contract Administrator deem it to be necessary. See athletic bidding schedule

Campus Buildings

1.6 **Pest Control:** The Offeror shall spray The Citadel's campus office buildings spaces, storage rooms, plus class rooms in the month of July. The Offeror shall inspect/treat the interior on a quarterly basis. The Offeror shall provide a monthly perimeter treat to the exterior of The Citadel's campus locations on a monthly basic with an appropriate pesticide in an effort to reduce the pest population before entering the locations.

<u>Termite control</u>: The Offeror will conduct inspections and treatments of the campus buildings during the months of Aug 1st and Oct 1st, with coordination with the contract's administrator. All reports must be completed on or Before November 1st of each year.

Residential Quarters

- 1.7 The Offeror shall treat the residential properties on a quarterly schedule to include four (4) exterior treatments plus one (1) interior treatment to all residential properties annually. It is recommend that this service be rendered quarterly and will be accomplished within the first three weeks of each quarter. The Offeror shall treat the exterior with insect bait pesticide, sprays, dust power or any other means to form a barrier around the property perimeter. The Offeror first (1st) quarterly treatment shall include a one (1) time interior treatment with the use of insect bait pesticide for each of The Citadel's residential property listed herein plus the exterior at the same time. The additional three (3) exterior treatments shall be accomplished in the same manner as prescribed herein excluding the interior. Due to the imminence work load, The Citadel shall suggest that the Offeror divide the campus residential quarters into four integral groups. The Offeror shall then take those properties within a particular quarter and treat one third (1/3) of the exterior thus completing the quarterly treatment during a monthly cycle.
- 1.8 The Citadel Contract Administrator will provide a schedule to the awarded offeror prior to the beginning of each quarter.

1.9 The Offeror shall inspect quarters one, (The President of The Citadel premises) and treat on an "as need" basis. Cost associated with this inspection and treatment will be calculated on a monthly basic and reflected on the bidding schedule as a separate line item. **See residential bidding schedule**.

Check In

2.0 The Offeror shall provide The Citadel's contract coordinator/contract administrator their scheduled service dates and the proposed units and building to be serviced during their visit on campus. Upon arrival to The Citadel campus, the Offeror representative shall be required to check in at the Physical Plant Contracts administrator to inquire on any additional service requirements that may be taken care of during that particular visit usually Tuesdays and Thursdays. The Citadel's contract coordinator/contract administrator shall occasionally monitor the Offeror technician during any of their visits to the campus to ensure compliance with the contract. The Citadel contract coordinator/contract administrator plus the Offeror technician and his supervisor shall meet quarterly to discuss treatment needs, problems, issues or concerns about the service. It will be during this meeting that The Citadel's contract coordinator/contract administrator shall receive the next quarter's service schedule. The Offeror shall provide a current accurate service schedule on the first Monday of the quarter.

2.1 Work orders

A work order for termite and pest control service will be provided to the Offeror as a source document identifying the residences and buildings that will be serviced with a description of services to be rendered. The termite or pest control technician will return the work order with an Offeror service report identifying the service provided and identification of chemicals used to treat and treatment method. The original work order sheet will be returned to the contract coordinator/contract administrator upon completion of work.

2.2 Spray

All treatment used in offices and administrative areas shall be Odorless. When treating residences ensure that the product being used will not interfere with the residence health and wellbeing and that of the pets in the residence.

\2.3 Standards

The application and appropriate use of all pesticide products is regulated and controlled by the State of South Carolina under State law, S.C. code of laws 1976, chapter 13, and title 46. The Offeror shall be required to follow all of the applicable laws regulated by the State under this cited source

2.4 Treatment

Exterior surface treatment of harborage areas includes removal of all spider webs, wasp nests, and dirt dauber nests at windows, entrances and doors to include all points of entry. Treatment, web and nest removal is applicable up to a vertical distance of 15 feet above the ground. This procedure is applicable to all treated structures at The Citadel. Rat and mice treatment and removal upon location and if possible, alive or dead, is required in buildings, structures and barracks, identified and listed in this contact.

Quarters having fleas will be treated at an additional cost to the housing occupant as established by the contractor.

2.5 **Products**

2.6 Emergency

The Offeror shall respond within two (2) hours of a service request notice for pest issues that are considered to be of an emergency or priority nature to The Citadel. Within that two (2) hour time frame, the Offeror shall treat infested areas with chemicals that will combat the infestation which may arise between scheduled visits. Example of an emergency service would be; rodents in a cadet living space / area or fire ants inside a structure and not typical sighting of a listed pest.

2.7 Evaluation

The pest control services provider shall be subject to inspection by The Citadel. All work not in accordance with this specification will be corrected within twenty-four hours after notification of a deficiency. The Offeror warrants to The Citadel that all pest control services performed within the specifications of this contract shall be accomplished in a professional manner consistent with industry practices

(B) Notice to contractor shall be to the address identified as the Notice Address on Page Two. Notice to the state shall be to the Procurement Officer's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph. [07-7A050-1]

OPEN TRADE (JUN 2015): During the contract term, including any renewals or extensions, Contractor will not engage in the boycott of a person or an entity based in or doing business with a jurisdiction with whom South Carolina can enjoy open trade, as defined in SC Code Section 11-35-5300. ORGANIZATIONAL CONFLICT OF INTEREST (APR 2023)

This disclosure shall include a description of actions which the Contractors has taken or proposes to take, after consultation with the Procurement Officer, to avoid, mitigate, or neutralize the actual or potential conflict.
- (b) The State may terminate this contract for convenience, in whole or in part, if it deems such termination necessary to avoid an organizational conflict of interest. Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not increase the obligation of the State beyond what it would have been if the subcontract had contained such a clause.

Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the

PUBLICITY (JAN 2006): Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

PURCHASE ORDERS (JAN 2006): Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

SURVIVAL OF OBLIGATIONS (JAN 2006): The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. BANKRUPTCY – GOVERNMENT INFORMATION (FEB 2015): (a) All government information (as defined in the clause herein entitled "Information Security - Definitions") shall belong exclusively to the State, and Contractor has no legal or equitable interest in, or claim to, such information. Contractor acknowledges and agrees that in the event Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, government information in its possession and/or under its control will not be considered property of its bankruptcy estate. (c) In order to protect the integrity and availability of government information, Contractor shall take reasonable measures to evaluate and monitor the financial circumstances of any subcontractor that will process, store, transmit or access government information. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.
- (4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

COMPLIANCE WITH LAWS (JAN 2006): During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs. [07-7B035-1]

CONTRACT LIMITATIONS (JAN 2006): No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

CONTRACTOR'S LIABILITY INSURANCE - GENERAL (FEB 2015): (a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.

(b) Coverage shall be at least as broad as:

If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy. (2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.

Any insurance or self-insurance maintained by the State, every applicable Using Governmental Unit, or the officers, officials, employees and volunteers of any of them, shall be excess of the Contractor's insurance and shall not contribute with it.
- (e) Prior to commencement of the work, the Contractor shall furnish the State with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by the State before work commences. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The State reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.
- (f) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the State immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.
- (g) Contractor hereby grants to the State and every applicable Using Governmental Unit a waiver of any right to subrogation which any insurer of said Contractor may acquire against the State or applicable Using Governmental Unit by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the State or Using Governmental Unit has received a waiver of subrogation endorsement from the insurer.
- (h) Any deductibles or self-insured retentions must be declared to and approved by the State. The State may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.
- (i) The State reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances.

The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders. (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State.
