Annually we have 5-6 standing COI's and over the last few years, we have seen 10-15 COI's to various agencies. The last couple of years we have provided COI's to athletics for off campus practice sessions prior to games (basketball, football, baseball and track).

Requestor 1: I have no recommendations for improvement at this time – we have a good working relationship with the Insurance Reserve Fund (IRF) and a good working relationship/understanding with our IRF rep along with the contracted adjusters assigned to all claims.

Requestor 2: Proactive offering of new insurance for areas we did not realize we had exposure.

Requestor 3: Explore what additional services insurance providers include, such as penetration testing and free legal consultation.

No, we do not. The parties are entitled to their advisor of choice, and if they do not have an advisor, we appoint one. The individual is an internal citadel employee.
