Please note that the Bunn Coffee Maker has been changed to Bunn Item# 346000.0006, Item# 34600.0007 is no longer available.

Questions and Answers

1. Do the items on this RFQ have to be delivered and set in place or can they just be drop shipped to your location?
A. Delivered to 10 Hammond Ave, Charleston, SC, 29409
2. Just to verify, installation is not needed, correct?
A. Installation is not required.
3. Can you please verify the model number of the Bunn Coffee Maker as 34600.0007 is not a valid model number. Per Bunn, that model is no longer being manufactured and is replaced by 34600.0000. Also, the servers or air pots are not included with this unit so please let me know if I need to quote those and which one you would prefer.
A. Please note change above from 34600.0007 to 346000.0006.
4. For the Crescor Holding Cabinet: we are able to select corner bumpers or a perimeter bumper, but not both. The perimeter bumper is the highest degree of protection so our quote will include that.
A. Perimeter bumpers.
5. For the Lincoln Impinger II: we have a quote that includes the options specified, however it does not include a cordset or stand. Is this a replacement, in which you already have these? Or are you interested in a quote for these?
A. Please quote with the stand and provide an option for the cord.
6. For the Bunn Coffee Makers: Bunn is not currently making this model in black, however they make it in stainless. I've attached a spec sheet for model 34600.0006 (same version except stainless), would you consider this option?
A. See response above – description of changes.
7. Can I get the delivery address for these units please?

A. Delivered to 10 Hammond Ave, Charleston, SC, 29409.

8. Could you please clarify what you require here?
Who is responsible for the installation? Should it be included in our quote or are we to quote drop ship to a dock location only?

A. Deliver to dock. Installation is not required.
