The Citadel requires continuation and enhancement of its enterprise vulnerability management and threat detection capability to maintain cybersecurity risk visibility, system integrity, and compliance across institutional information technology assets. The required capability must operate within the College's existing deployed security architecture to ensure uninterrupted monitoring, remediation, and risk response activities without introducing operational gaps or system disruption.

Describe the Market Based on Research Performed: *(See instructions on last page for guidance)*

The market for enterprise vulnerability management and threat detection solutions includes multiple commercial vendors offering software platforms with varying architectures, agents, analytics models, and deployment requirements. Market research confirmed that these platforms are not interoperable with one another and require full replacement of agents, reconfiguration of monitoring infrastructure, and migration of historical data to transition between vendors.

The Citadel has utilized the Rapid7 platform as its enterprise vulnerability management solution since approximately 2018, with agents deployed across institutional endpoints and servers. The requested products represent proprietary subscription enhancements within the existing Rapid7 environment. No implementation services are required because the platform and agents are already deployed.

Alternative vendors were evaluated at the time of original platform selection and would require full system replacement, re-agenting, retraining, and operational transition, resulting in unacceptable cybersecurity risk and substantial duplication of cost. The requested subscriptions can only function within the existing Rapid7 platform and cannot be provided by another vendor or integrated into a competing system.

The products will be obtained from Software House International as an authorized public-sector reseller of Rapid7 software. Software House International will not perform implementation or consulting services as part of this procurement.

Rapid7 is the only solution that meets The Citadel's requirement because the requested products are proprietary enhancements that operate solely within the existing Rapid7 platform already deployed across the institution. No other vendor can provide these capabilities without requiring complete replacement of the current vulnerability management environment.

Transitioning to an alternative platform would necessitate removal and replacement of deployed agents, reconfiguration of security infrastructure, retraining of personnel, migration of historical data, and a period of reduced cybersecurity visibility, creating unacceptable operational and security risk. The requested subscriptions extend and enhance existing capabilities without disruption and represent continuation of an established enterprise system rather than acquisition of a new solution.

Based on market research and technical evaluation, no other vendor can reasonably meet the agency's need without substantial duplication of cost or unacceptable delay. Accordingly, this procurement qualifies as a sole source under SC Code Ann. §11-35-1560 and SC Regulation 19-445.2105.
