Q: Can we make multiple offers per garment style as long as they meet the specification criteria for that garment?

A: Yes, multiple offers may be provided for a garment style, but a separate version of Appendix G must be provided for each offer to allow for accurate comparison of all bids received.

Q: Does the "high visibility" workwear request for the grounds crew's shirts and pants require an ANSI Class 2 or Class 3 classification like their jacket does?

A: Class 2 certification is sufficient for grounds crew shirts and pants.

Q: You are requesting 100% cotton shirts and 100% cotton pants for your Utilities folks which are non-compliant with the most recent guidelines from NFPA 70e in regards to work apparel for employees working on or near energized parts. Would you like an offer for compliant Level 2 arc rated shirts and pants as well to match their Level 2 jacket?

A: No, Level 2 shirts and pants are NOT requested in this IFB for Utilities Wear. The College already has work wear and equipment in place for employees working with energized equipment.

Q: On the Offer's Checklist there is a request to not provide standard contract forms yet on page 17 it asks for a copy of the standard contract. Should we submit our contract with our offer or exclude it?

A: Yes, if the Offeror has a standard rental or lease agreement, it should be included with the bid.
