The Citadel reserves the right to award all ATM locations to a single Contractor, or to make separate awards to multiple Contractors if it is in the best interest of the College to do so. Additional ATMs may be requested in the future, if needs dictate, for areas to be determined at a later date.

**ACQUIRE SERVICES (JAN 2006):** The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions. [01-1010-1]

**MAXIMUM CONTRACT PERIOD -- ESTIMATED (JAN 2006):** Start date: April 1, 2021 End date: March 31, 2026. Dates provided are estimates only. ## II. INSTRUCTIONS TO OFFERORS

### A. GENERAL INSTRUCTIONS

**AUTHORITY** means the State Fiscal Accountability Authority or its successor in interest.

**BUSINESS** means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity. [11-35-310(3)]

**CHANGE ORDER** means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract. [11-35-310(4)]

**DISCLOSURE OF CONFLICTS OF INTEREST OR UNFAIR COMPETITIVE ADVANTAGE**

### **III. SCOPE OF WORK/SPECIFICATIONS**

The Citadel is inviting proposals for the installation and servicing of free-standing Automated Teller Machines (ATMs) located in the lobby of Mark Clark Hall, the coin laundry area, and in the Athletic venues. The Citadel reserves the right to award all ATM locations to a single Contractor, or to make separate awards to multiple Contractors if it is in the best interest of the College to do so. Additional ATMs may be requested in the future, if needs dictate, for areas to be determined at a later date.

#### **Background:**

Mark Clark Hall is located in the heart of The Citadel's campus and houses a food court, Book Store, Starbucks, Post Office, Barber Shop, student lounge, and the Offices of Cadet Activities. It is The Citadel's central point for campus visitors/guests to its campus and currently houses one (1) free-standing ATM that is owned and operated by South Carolina Federal Credit Union. Mark Clark Hall will continue to house only a single ATM and the awarded Contractor for this location shall install their ATM in the exact same location that the current ATM is situated. The Contractor shall coordinate the installation of their equipment with the removal of the current ATM provided by South Carolina Federal Credit Union.

The Citadel Coin Laundry is a facility that is located near the student barracks (housing) and is currently accessible to students twenty-four (24) hours per day, seven (7) days per week. No ATM is currently present at this location and one (1) unit will be placed in that space as the result of the award of this RFP.

Currently, no ATMs are present in the Athletic venues on campus, and The Citadel would like to provide up to two (2) additional ATMs that will service these locations as recommended by the awarded Contractor for this portion of the RFP. Johnson Hagood Stadium and McAlister Field House are the two primary Athletic facilities on campus and are utilized heavily during football and basketball seasons. The Athletic Department also rents these facilities to outside entities for community events and performances throughout the year. ATM services in these areas will not only be available to students, faculty, and staff, but also anyone coming to events in these facilities. Based on mutual agreement between The Citadel and the awardee, these ATMs may be placed permanently, or on a per event basis. If units are placed per event, it is the responsibility of the awardee to coordinate installation and removal, along with any associated costs, for each event. ATMs must be available at each location for events during the date ranges listed below.

Johnson Hagood Stadium East Concourse: One (1) ATM available for all events mid-August through mid-January.

McAlister Field House: One (1) ATM available for all events October through March.

**Requirements:**

The Contractor shall furnish and install, at no cost to The Citadel, the ATM and all equipment associated with the installation of the ATM to include all connection/interfaces software, and cabling/telephone wiring. The Contractor must assume the responsibility for all costs related to the operation of the ATM equipment including, but not limited to, currency, security, insurance, and service personnel.

ATMs must be new or like new, compact, not affixed, and measure approximately two feet (2') wide by four feet (4') deep by six feet (6') tall; used equipment is acceptable. If the Offeror's equipment exceeds these dimensions, the offeror must provide their equipment dimensions with their proposal. These dimensions shall be inclusive of any surround for marketing purposes; all equipment must fit the space provided both structurally and aesthetically. These units will remain the property of Contractor at all times and shall not be construed as a fixture. Drawings must be supplied for any and all models of ATMs offered in your proposal, along with a specification sheet identifying all environmental and utility requirements for installation. Offeror shall make no modifications or alterations to any equipment, area, space or structural component of the ATM space without the prior written approval of The Citadel.

The Contractor shall have the obligation, upon termination of agreement, to remove the ATM placed on College premises within fifteen (15) days of termination. ATM provider shall at its sole expense, repair any damage to the premises caused by such removal. Upon termination of any agreement arising from this RFP process, the provider of ATM services shall vacate the premises and deliver the premises to the College in the same condition that the premises are in at the time of installation of equipment or subsequent improvements, alterations or additions, reasonable wear and tear excepted.

Upon termination of any contract arising from this RFP and/or removal of the ATM, all conduit and electrical, computer, telephone, and other lines which serve the ATM will remain the property of the College. The Citadel assumes no responsibility for security precautions or measures with respect to the ATM and will in no way be responsible for any loss, or damage to, or contents of same, except loss occasioned by negligence or willful act of the College or the College's agents, employees, and servants while serving within the scope of their employment. A student of The Citadel does not constitute an agent, employee, or servant of the College.

The annual amount to be paid to The Citadel for each proposed ATM will be included in the offeror's proposal. Although the offerors will provide an amount for any ATM listed in the financial offer, the College reserves the right to negotiate with successful offerors to establish the final fee paid. A five percent (5%) annual fee increase effective on the anniversary date is to be applied for each of the succeeding years after the initial term for all ATM contracts awarded.

### **Contractor Responsibilities**

1. Contractor will identify one member of its staff as a point of contact for ATM installation, related problems, and contract administration matters, along with any other issue related to the operation of the installed ATM.
2. Service calls must be addressed within twenty-four (24) hours and the ATM may not be out of service (or out of currency) for a period longer than forty-eight (48) hours.
3. Contractor is solely responsible for the oversight of the installation, consistent maintenance, and modernization of the specified equipment and all related expenses of such activities.
4. Contractor is the sole owner or lessee of the ATM and related equipment, and shall be in sole control of the nature and scope of the operation of the ATM.
5. Have the approval of all applicable federal, state, and local regulatory agencies governing or providing oversight to banking transactions, and may be required to obtain additional regulatory approvals as deemed necessary by the College.
6. Adhere to prevailing merchandising and advertising policies of the College. The offeror will provide a marketing plan to The Citadel to include all printed marketing materials and marketing staff for specific scheduled events to market services currently being offered by the financial institution.
7. ATM equipment will offer at least the following minimum banking services:
  - a. Withdrawals and access to a minimum of three (3) major national networks.
  - b. Security camera with video accessible to College police personnel for resolution of issues as they arise with information as to web addressable IP capability of camera.
  - c. Dispense money in \$10 and \$20 increments.
  - d. Cash advances from either debit or credit cards.
  - e. Account balance inquiries.



8. Contractor will at its sole cost and expense provide installation of:
  - a. Telephone and computer line carrier service and all other equipment, to include wiring, conduit, face plates, junction boxes, and other modifications necessary to tap into data/telephone communications link and dedicated electrical power.
  - b. Coordinate with The Citadel IT Department, and telephone company to set up connectivity between the ATM and the offeror's banking environment through the use of such technologies as may be consistent with the College's IT procedures and policies. The offeror accepts all responsibility for wiring and connection.
  - c. Internal security measures to safeguard ATM transactions and electronic means of determining the functionality of the ATM.
  - d. The College prefers ATMs that operate via cellular or wireless signal.
9. Contractor, its employees, independent contractors, and agents shall have access during normal business hours for the purpose of installing, maintaining, servicing, operating, and removing the ATM. The contractor must have the capacity to service the ATM with sufficient frequency so that currency is not depleted, thereby shutting down the ATM. Use of armored car carriers, or other providers, which would carry weapons onto The Citadel campus must meet SC state statutes governing such.
10. Contractor and the College will mutually agree upon the appearance, location, and all other features and characteristics of the lines, facilities, and equipment serving the ATM.
11. If College premises are destroyed or damaged by wind, fire, smoke, rain, or other casualty or vandalism, the College and financial institution providing ATM equipment shall cooperate to rebuild or repair the premises to a condition substantially equivalent to the condition thereof at the time of such destruction or damage. The cost of such rebuilding or repairing shall, to the extent that the same represents the cost of providing facilities substantially equivalent to the premises as of the commencement date of an agreement, be paid by the College. The remainder of the cost of such rebuilding, repairing, or equipment replacement shall be paid by the ATM provider.

If the premises are destroyed by wind, fire, smoke, rain, or other casualty or vandalism or damaged by same to such an extent as to render impossible the use of same by the financial institution, College and financial institution shall each have the option to terminate the agreement by giving written notice within ten (10) days of such destruction or damage.

No claim for damages may be made by either party as a result of interruption to the provision of the ATM provider's services resulting from civil or student unrest, disobedience, strike, or sabotage, pandemics, or other "acts of God," but both parties will employ diligent efforts to repair and resume services as quickly as possible.

It is understood that no claim will be made by the contractor in the event that the College decides to temporarily suspend and close services due to the aforementioned style of disorder. It shall also be agreed the College has no responsibility for a utilities or mechanical breakdown which could cause a disruption or suspension of the ATM provider's services, but College agrees that it will use all reasonable efforts at its command to repair such a breakdown in order to make possible a resumption of services as expeditiously as possible.

12. Proof of the required insurance must be provided within ten (10) days of notice of contract award.
13. Subject to College approval, the contractor may place signs and other normal business logos on the ATM only. All such signs or other logos placed on the premises will need to be pre-approved by the College prior to installation. All such materials will be deemed to be the personal property of the contractor and may be removed upon termination of the contract. The contractor will be responsible for any costs associated with installation and/or removal of related signage. The contractor shall provide the College with a high-quality electronic version of their logo for inclusion on College webpages and print and marketing materials.
14. Proposals must demonstrate a minimum of five (5) years' experience in supplying the required service to facilities similar in size and scope as those required herein. The College reserves the right to use reference checks in its evaluation of proposals. It is the offeror's responsibility to provide valid reference information.
15. Installation must be completed within thirty to forty-five (30-45) days from receipt of contract award notification.
16. Notify patrons of any and all applicable fees prior to their use of the machine by either posting a message in hard copy on the ATM and/or providing for an electronic notice prior to the completion of a transaction.
17. Quarterly, Contractors will report on transaction unit (not \$) volumes, service calls and resolution time listed by month.

### **Citadel Responsibilities**

1. Supply the electrical service to the ATM sites and pay for all electrical charges during the term of agreement reasonably incurred to operate the ATM.
2. Be responsible for maintenance of the facility housing the ATM and its adjacent areas.
3. Secure fire and extended coverage protection of the structure housing the ATM equipment, but will not be responsible for the actual ATM or its contents.
4. Take all reasonable measures to cooperate with the offeror in preventing damage to the ATM or theft there from, but shall not be liable for such damages, theft, or injury that may occur in connection with any ATM equipment.
5. The Citadel shall allow and provide space for the awarded offeror to market financial services provided to students and staff through the supportive financial institution.
6. Authorize specific opportunities for the awarded offeror to market a variety of banking services to incoming freshmen and their parents, upper class students, and The Citadel's faculty and staff.
  - a. An example of such opportunities may include, having space available during freshman orientation, space available to register upper class Cadets at the beginning of each semester, and/or space available during faculty and staff benefits fairs.

**VII. TERMS AND CONDITIONS**

**A. GENERAL**

**ASSIGNMENT, NOVATION, AND CHANGE OF NAME, IDENTITY, OR STRUCTURE (FEB 2015):**

(a) Contractor shall not assign this contract, or its rights, obligations, or any other interest arising from this contract, or delegate any of its performance obligations, without the express written consent of the responsible procurement officer. The foregoing restriction does not apply to a transfer that occurs by operation of law (e.g., bankruptcy; corporate reorganizations and consolidations, but not including partial asset sales). Notwithstanding the foregoing, contractor may assign monies receivable under the contract provided that the state shall have no obligation to make payment to an assignee until thirty days after contractor (not the assignee) has provided the responsible procurement officer with (i) proof of the assignment, (ii) the identity (by contract number) of the specific state contract to which the assignment applies, and (iii) the name of the assignee and the exact address or account information to which assigned payments should be made. (b) If contractor amends, modifies, or otherwise changes its name, its identity

(including its trade name), or its corporate, partnership or other structure, or its FEIN, contractor shall provide the procurement officer prompt written notice of such change. (c) Any name change, transfer, assignment, or novation is subject to the conditions and approval required by Regulation 19-445.2180, which does not restrict transfers by operation of law. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation. (2) Service of Process. Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to the Agreement; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided as the Notice Address on Page Two or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail. [07-7A025-1]

**EQUAL OPPORTUNITY (JAN 2006):** Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference. **FALSE CLAIMS (JAN 2006):** According to the S.C. **FIXED PRICING REQUIRED (JAN 2006):** Any pricing provided by contractor shall include all costs for performing the work associated with that price. **PAYMENT & INTEREST (FEB 2015):** (a) The State shall pay the Contractor, after the submission of



proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the Government. (b) Unless otherwise provided herein, including the purchase order, payment will be made by check mailed to the payment address on "Page Two." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off. [07-7A055-3]

**PUBLICITY (JAN 2006):** Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

**PURCHASE ORDERS (JAN 2006):** Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

**SURVIVAL OF OBLIGATIONS (JAN 2006):** The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

**TAXES (JAN 2006):** Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. **TERMINATION DUE TO UNAVAILABILITY OF FUNDS (JAN 2006):** Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefor. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

**THIRD PARTY BENEFICIARY (JAN 2006):** This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. [07-7A090-1]

**WAIVER (JAN 2006):** The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

## **B. SPECIAL**

**COMPLIANCE WITH LAWS (JAN 2006):** During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs. [07-7B035-1]

**CONTRACTOR'S LIABILITY INSURANCE - GENERAL (FEB 2015):** (a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.

(b) Coverage shall be at least as broad as:

(1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.

(2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.

(3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.

(c) Every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.

(d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance

as respects the State, every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them. Any insurance or self-insurance maintained by the State, every applicable Using Governmental Unit, or the officers, officials, employees and volunteers of any of them, shall be excess of the Contractor's insurance and shall not contribute with it.

(e) Prior to commencement of the work, the Contractor shall furnish the State with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by the State before work commences.

However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The State reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.

(f) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the State immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.

(g) Contractor hereby grants to the State and every applicable Using Governmental Unit a waiver of any right to subrogation which any insurer of said Contractor may acquire against the State or applicable Using Governmental Unit by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the State or Using Governmental Unit has received a waiver of subrogation endorsement from the insurer.

(h) Any deductibles or self-insured retentions must be declared to and approved by the State. The State may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.

(i) The State reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances.

**CONTRACTOR PERSONNEL (JAN 2006):** The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

**CONTRACTOR'S OBLIGATION – GENERAL (JAN 2006):** The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

**DEFAULT (JAN 2006):** (a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension; (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause). (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure. (b) If the State terminates this contract in whole or in part, it may acquire, under the

terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated. (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor. (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule. (e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as “manufacturing materials” in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest. (f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor’s rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders. (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor’s rights under the Disputes clause. (h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]

**ILLEGAL IMMIGRATION (NOV 2008):** (An overview is available at [www.procurement.sc.gov](http://www.procurement.sc.gov)) By signing your offer, you certify that you will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agree to provide to the State upon request any documentation required to establish either: (a) that Title 8, Chapter 14 is inapplicable to you and your subcontractors or sub-subcontractors; or (b) that you and your subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, “A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both.” You agree to include in any contracts with your subcontractors language requiring your subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in their contracts with the sub-subcontractors language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14. [07-7B097-1]

**INDEMNIFICATION-THIRD PARTY CLAIMS – GENERAL (NOV 2011):** Notwithstanding any limitation in this agreement, and to the fullest extent permitted by law, Contractor shall defend and hold harmless Indemnitees for and against any and all suits or claims of any character (and all related damages,

settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third party which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property arising out of or in connection with the goods or services acquired hereunder or caused in whole or in part by any act or omission of contractor, its subcontractors, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnatee, and whether or not such claims are made by a third party or an Indemnatee; however, if an Indemnatee's negligent act or omission is subsequently determined to be the sole proximate cause of a suit or claim, the Indemnatee shall not be entitled to indemnification hereunder. Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees. [07-7B100-2]

**LICENSES AND PERMITS (JAN 2006):** During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. [07-7B115-1]

**RELATIONSHIP OF THE PARTIES (JAN 2006):** Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party. [07-7B205-1]

**SUBCONTRACTOR SUBSTITUTION PROHIBITED - RESIDENT SUBCONTRACTOR PREFERENCE (SEP 2009):** If you receive an award as a result of the subcontractor preference, you may not substitute any business for the subcontractor upon which you relied to qualify for the preference, unless first approved in writing by the procurement officer. If you violate this provision, the State may terminate your contract for cause and you may be debarred. In addition, the procurement officer may require you to pay the State an amount equal to twice the difference between the price paid by the State and the price offered by the next lowest bidder, unless the substituted subcontractor qualifies for the preference. [11-35-1524(D)(5)(c)] [07-7B237-1]

**TERM OF CONTRACT – EFFECTIVE DATE / INITIAL CONTRACT PERIOD (MODIFIED):** The effective date of this contract is the first day of the Maximum Contract Period as specified on the final statement of award. The initial term of this agreement is two (2) years from the effective date. Regardless, this contract expires no later than the last date stated on the final statement of award.

**TERM OF CONTRACT – OPTION TO RENEW (MODIFIED):** (a) At the end of the initial term, and at the end of each renewal term, this contract shall automatically renew for a period of one (1) year unless contractor receives notice that the state elects not to renew the contract at least thirty (30) days prior to the date of renewal. Regardless, this contract expires no later than the last date stated on the final statement of award. (b) Contractor acknowledges that, unless excused by Section 11-57-320, if the contractor is on the then-current Iran Divestment Act List as of the date of any contract renewal, the renewal will be void ab initio.

**TERM OF CONTRACT – TERMINATION BY CONTRACTOR (JAN 2006):** Contractor may

terminate this contract at the end of the initial term, or any renewal term, by providing the Procurement Officer notice of its election to terminate under this clause at least ninety (90) days prior to the expiration of the then current term. [07-7B250-1]

**TERMINATION FOR CONVENIENCE – SHORT FORM (JAN 2006):** The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. In such a termination, the Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called “manufacturing material”) as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. Upon such termination, the contractor shall (a) stop work to the extent specified, (b) terminate any subcontracts as they relate to the terminated work, and (c) be paid the following amounts without duplication, subject to the other terms of this contract: (i) contract prices for supplies or services accepted under the contract, (ii) costs incurred in performing the terminated portion of the work, and (iii) any other reasonable costs that the contractor can demonstrate to the satisfaction of the State, using its standard record keeping system, have resulted from the termination. The contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided. As a condition of payment, contractor shall submit within three months of the effective date of the termination a claim specifying the amounts due because of the termination. The absence of an appropriate termination for convenience clause in any subcontract shall not increase the obligation of the state beyond what it would have been had the subcontract contained such a clause. ## APPENDIX D

# Instructions for Non-Resident Taxpayer Registration

### IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation. A person is not required to withhold taxes for a nonresident taxpayer who submits an affidavit certifying that they are registered with either the South Carolina Secretary of State or the SCDOR.

#### **REQUIREMENTS TO MAKE WITHHOLDING PAYMENTS**

Code Section 12-8-550 requires persons hiring or contracting with a nonresident taxpayer to withhold 2% of each payment made to the nonresident where the payments under the contract exceed \$10,000.

However, this section does not apply to payments on purchase orders for tangible personal property when those payments are not accompanied by services to be performed in this state.

Code Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation.
